Towing from Resurfacing

Member forum - Derrick Lawson owner of 2110 #301. Tenants contacted owners because they returned home on Sunday night (around 1 a.m.), and no car was present. Owners called police. Contacted owner a few days later. Derrick contacted Eric. Board - gave 72 hour's notice. Schedule for work was set the Wednesday before - notices posted on Tuesday. Towed a total of 6 cars, at association expense due to short notice. Derrick has a few concerns. Tenants threatened legal action. If damage to the vehicle - they will want it fixed. Another resident also called police about their car being missing, but found the car almost immediately. Eric - lesson learned. Coordinating 144 units, we need to make executive decisions. Derrick - will be in touch with the board regarding the results of his conversation with his tenants. Board will take action based upon that conversation.

New Business

Various lights are out on west end of Ivystone, including some or all ground lights, some or all carport lights, some or all lights near west side of South Lakes entrance. Not known at this point if problem is Dominion's or Woodwinds. Teri will find provide Diana with the location of the pedestal meter, info on what lights are on pedestal, account number, etc, and then Horizon will follow up with Dixie and/or Dominion.

Teri motion – have M&WR clean carpets in garden style stairwells for \$1020. Has been budgeted for. Patrick second. Passed unanimously.

Teri motion – have M&WR clean windows in garden style stairwells for \$850. Has been budgeted for. Patrick second. Passed unanimously.

Teri, Diane, and Eric met with lawyer, who had reviewed the governing documents. Suggested that quorum and handling of proxies be revised first, and then additional changes made after new quorum and proxy rules are in place.

Annual Meeting - Teri will prepare budget. Eric will prepare a letter and other documents for mailing.

Lawyer recommended board join Community Association Institute. Diane to get cost info for board decision.

Kate Davidson - Teri had a 30 minute conversation with Kate. Teri see if she can be at the annual meeting. Good to have tree removal and drainage work prices locked in for entire project. Market is rebounding for trees and plants, landscaping, walls, so actual costs will probably be more than estimated in 2012. Kate needs to rework plan for trees, plants, landscape work for this fall, as well as work to be done in 2014. Likely to run \$20k more than the \$47k estimated in 2012.
