- On December 6, vote to approve ECO Northern Virginia Insulation proposal to upgrade insulation in all units, that have attics, to US Department of Energy standard of R-49 in the amount of \$95,810.

Old Business

- Attic Insulation Project.
 - 43 of the 62 units have scheduled appointments. Eric is asking HCS to contact the remaining missing units to get scheduled. Or find a way to the association to force their way into units for the project to be completed.
 - ECO is inspecting attics while blowing insulation.
 - Some units have insulation, but those owners are aware that ECO still needs to inspect those attics.
 - Gay Bridges attic hatch. HCS will get an update on the status of their current hatch.
- Gutter cleaning. 11616 WBC rear gutter didn't get cleaned, it's a double gutter. Need to make sure the 3 cleanings in 2016 that we have that one rear gutter. It's the only building that has a rear gutter.

New Business

- Eric motions to accept a bid from The Foundation Expert for water proofing/drainage installation at 11642 and 11644 Ivystone Court for \$15,785. Teri second. All approve.
- HCS will send the board the painting contract proposal from Advantec for an e-mail vote later this month.
- 2102 GWW #301 needs new cable run by Comcast. Board informs HCS to coordinate access for the units to #101 and #201.
- HCS transfer of contract to Sentry Management. Board will discuss and

- make a decision before the next board meeting.
- Does the board have the ability to heat units at 2108 GWW #101, 11610 ISC. HCS will look into the ability of the board to force units to heat so that pipes don't burst.
- Repair of wall at 11608 ISC to 11610 ISC. HCS will tell 11608 that the plan is to grind the stump at 11608 ISC, then repair the wall.
- Kiddco needs to come out and do preventive maintenance on the boilers. HCS will contact Kiddco and coordinate the maintenance.

Action Items

- 13332 - Boiler State Inspection. Completed. Needs to be completed and certified every 2 years. Currently waiting for certificates.
- 13333 - Matilda Lawrence. Contract has been awarded to Foundation Expert.
- 13334 - 11642 leak issue. Cutting Edge still needs to come out and inspect and attempt to stop the leak. Or identify the source and if it's the unit owners responsibility.
- 13493 - Dryer vent cleaning and covers. HCS is still coordinating to get a bid for cleaning and putting new covers on.
- 13503 - Dominion Lights. Still need to figure out the credit for the missing light.
- 13509 - Dixie. Adding hall fixtures to the monthly inspection of lights. HCS will look into it.
